# Minutes of Sawley Parish Council Meeting held on Tuesday 24 October 2017 at 7.00pm at the Wesley Methodist Hall.

#### 134/17 Apologies for absence

**RESOLVED** to note the apology for absence received from Councillor Simmons.

# 136/17 Co-option of new councillors

**RESOLVED** that Mr C Corbett and Ms S Dawson be formally co-opted on to the Parish Council and the Acceptances of office were completed.

#### 137/17 Public Speaking

- (a) It was reported that the garage on Tamworth Road was still parking cars for sale across the double yellow lines. It was confirmed that wardens from Erewash Borough Council had visited the premises to warn them and the police had attended on 14 October 2017.
- (b) It was suggested that a gate be placed on the Anstey Road entrance to Lakeside Park and the Parish Council was asked to look into this as an option for the 2018/19 budget. Cllr Aram agreed to look into further and feedback prior to the Council approving the 2018/19 budget.
- (c) Derbyshire County Councillor Athwal confirmed that the road works on Tamworth Road should be completed by the end of next week. This was due to essential works and it was acknowledged that it had created a lot of congestion.

# 140/17 Reports from Cllr T Aram

- (a) Remembrance Service Parade Cllr Aram gave an overview of this year's event plan. Cllr Aram confirmed that the road closure had been approved and all the signage ordered etc. A meeting had taken place with All Saints' Church and representatives from the local scouts and brownies to finalise the parade. This year additional marshalls had been hired to prevent people spilling off the pavement onto the road. The Vicar will also remind people not to walk on the road prior to entering the official road closure. A letter had been sent out to all the properties affected by the road closure and KAMs serving garage. Mr John Hey-Heddle would be the master of ceremonies and would be bringing the generator. Cllrs Aram and Richardson will put up all the road signs prior to event.
- (b) Erewash in Bloom Cllr Aram entered Sawley Parish Council into the Erewash in Bloom completion for the recent street improvements at Long Eaton station. Sawley Parish Council have been awarded joint second in the 'Best Street, Community Area or Friends Group'. The certificate and glass trophy will be displayed in the stations ticket office. The event was attended by Cllr Aram, Cllr Powell and Cllr Richardson.

- (c) Community Rail Awards (ACoRP) Cllr Aram entered Sawley Parish Council into the ACoRP awards and confirmed that Sawley Parish Council was awarded 3<sup>rd</sup> place in the 'Most Enhanced Station Buildings and Surroundings' category throughout the whole United Kingdom. The ceremony was held at Derby Roundhouse and Cllr Aram was presented with a trophy as well as a presentation certificate. These will also be displayed within the ticket office at Long Eaton station.
- (d) NALC Star Councillor Award Cllr Powell confirmed that Cllr Aram was now in the final 3 for the Councillor of the Year Award. The award ceremony will take place in Milton Keynes on 30 October and attended by Cllr Aram and Cllr Powell.

# 141/17 Statement of Persons Nominated and Sawley By-election

The Statement of Persons Nominated was published on the Sawley Parish Council website on 11 October 2017 and the election will take place on Thursday 2 November 2017. Denise Bond the labour candidate and John Hey-Heddle the conservative candidate were standing.

# 142/17 Parish Clerk Report

(a) Poll cards for by election update – the clerk confirmed that the cost of the election would be significantly reduced if the parish council decided not to have poll cards. If poll cards were printed/delivered the Parish Council would be charged approximately £5,500 by Erewash Borough Council for delivering the election.

Cllr Briggs confirmed that residents did not need a poll card to vote and that the cost for provision of poll cards was £1,900 which would have a significant impact on the council's budget. The election will also be published on the council's notice boards as well as on the website.

**RESOLVED** all councillors in attendance unanimously agreed that due to the high cost the Parish Council will request that polling cards are not provided by Erewash Borough Council for this election.

**RESOLVED** to note that the road closures had been completed and approved by Erewash Borough Council.
